As the use of firearms is dangerous, we require all shooters to acknowledge that they are aware of all risks by signing this declaration and to accept the resulting consequences.

General:

This liability waiver is limited to the multi-day event "SASS Sanctioned Open Lower Austrian Championship Wild Bunch 2026 / SASS Sanctioned Open Lower Austrian Championship CAS 2026

2nd Woodquarter Gunfight CAS," which will take place from May 14-17, 2026, at the Kleinotten shooting range.

The discipline "Wild Bunch Action Shooting & Cowboy Action Shooting" discipline involves the use of weapons and live ammunition while standing, walking and running and requires certain actions and movements to be performed depending on the scenario.

All shooters and their companions are therefore aware that the organizers and officials (e.g. Match Director, Club Chairman, Posse Marshall, Deputy) are in no way responsible for the safety of a competitor and his/her companion or assume any other form of responsibility.

- The shooter confirms that he/she is aware of the safe handling of weapons and ammunition.
- The shooter is aware of the fact that the use of weapons and live ammunition and their handling under stress in a competition situation is dangerous and could cause injury or death to themselves and/or others if the weapon is handled improperly.
- Each shooter is responsible for each shot fired and is liable for any injury or damage to persons or the shooting range equipment.
- The organizer is not liable for damage to the property of the shooters and the participating shooters, accompanying persons and visitors.
- Every shooter is aware that participation in the event is only permitted with a firearms licence and he/she is aware of the current national laws.
- Interpersonal conflicts will not be tolerated at any level and at any time. The participants concerned will be excluded from the event immediately and without exception.
- The "carrying" of weapons is only permitted in the context of shooting sports. No weapons are permitted in the office and canteen areas.
- Shooting over the rampart is prohibited and will result in immediate exclusion from the event. Furthermore, this offense will be prosecuted under civil law.
- • Shooting over the wall toward the bullet trap is prohibited and will result in immediate exclusion from the event. Furthermore, this offense will be prosecuted under civil law.

New features for 2026

The SJV Zwettl and the SASS CAS Austria sports shooting association accept no liability for damage to parked cars and motorhomes. This applies in particular to:

- Stone chips & splinters: Damage caused by ricochets or flying particles.
- Tire damage: No liability for flat tires or punctures.
- General: Use of the parking lot is at your own risk.

Liability notice regarding the long-range facility. The SJV Zwettl and the SASS CAS Austria sports shooting association accept no liability for improper use of the facility. Each shooter acts on their own responsibility.

Damage to the cable pull system (whether accidental or deliberate) must be reported immediately; the costs incurred will be borne by the person responsible.

Photography and filming are permitted for personal use, but the publication of recordings on social media (YouTube, Facebook, Instagram, Twitter, TikTok, etc.) is generally only permitted with the consent of the organizer, the SASS CAS Austria sports shooting association.
