

„ Days of Truth 2026“ - GENERAL RELEASE FROM LIABILITY

SINCE THE USE OF FIREARMS IS DANGEROUS, WE REQUIRE ALL SHOOTERS TO ASSUME ALL RISKS BY SIGNING THIS RELEASE.

The **Days of Truth 2026** is a Cowboy Action Shooting competition, taking place from July 13. to 19. 2026. at the shooting range in ŠSK Domaniža, Domaniža č.416, 018 16 Domaniža, Slovakia

The **Days of Truth 2026** is a competitive Cowboy Action Shooting event that involves the use of guns and live ammunition while standing, walking, running and/or include the demand to perform certain actions and movements or exercises that are stated in individual guidelines and stage design scenarios. All competitors are further required to be attired in historical, period correct costumes and apparel typical to the area of the “Old West” prior to ca. 1880. Such garments and accoutrements may limit or hamper the abilities of the individual shooter to move in a manner he/she is usually accustomed to. All shooters/competitors and their accompanying relatives, spouses and children will therefore understand that the organizers and sponsors, as well as the official representatives including such official persons as Sponsors, Match Director, Range Master(s) and Range Officer(s) will in no way be responsible – or accept any other form of responsibility – for the safety of any competitor or the persons accompanying him/her at any time.

I understand that I’m participating in a sport which contains dangers, and risks may arise, including but not limited to accidental injury, the forces of nature and illness. In consideration of the right to participate in this event and the services provided for me by the Slovak Association of Western Shooting and the shooting range ŠSK Domaniža, Domaniža č.416, 018 16 Domaniža, I have and hereby assume the risks associated with such events and I agree to the provisions set forth below:

- Each and every shooter/competitor will at all times be aware that the use of guns and live ammunition and handling/employing them under stress in a competitive situation is dangerous, and furthermore he/she will at all times be aware and alert to the fact that these weapons can cause injury or death to himself/herself and/or other persons.
- Each and every shooter/competitor is solely responsible for the safe condition of the guns and ammunition that he/she may be using during the entire competition including all side events and matches.
- Each and every shooter/competitor is responsible, and will answer for, any injury or damage inflicted upon any persons or done to any part of the shooting range ŠSK Domaniža, Domaniža č.416, 018 16 Domaniža, Slovakia where the event DAYS OF TRUTH 2026 will be performed.
- The organizer is not responsible for damage to property of shooters, their family members and escorts, and visitors.
- Each and every shooter/competitor will inquire into, understand, and at all times comply with the international, national and local laws concerning the possession, handling, and transport of his/her guns and ammunition while traveling to and from Slovak Republic, and participating in the DAYS OF TRUTH 2026 in Domaniža.
- Interpersonal conflicts will not be tolerated at any level or at any time, all participants in such interpersonal conflicts will immediately be removed from the competition and the shooting range without exception.

- No guns may be carried in any form on any part of the person during times in which alcohol is available or being served. No guns will be allowed in areas providing entertainment that includes bar and restaurant.
- The Match Director can at his discretion permit certain official persons to bear arms at all times while engaging in matters pertaining to security or to ensure the safety of all persons on the shooting range and/or their property and belongings. These individual persons will be posted by name/function and will be recognizable at all times.
- During the event, a professional team will take several records: I agree that you may tape and photograph me, eventually record my voice, conversations and sounds, including every performance of any musical composition(s), during and in connection with my appearance. All these records could be used in any and all media and in the promotion, advertising and exploitation of Cowboy Action Shooting events and/or otherwise, in connection with Slovak Association of Western Shooting throughout the world, an unlimited number of times in perpetuity. I further represent that any statements made by me during my appearance are true, to the best of my knowledge, and that neither they nor my appearance will violate or infringe upon the rights of any third party.

Consent with processing of Personal data.

Slovak Association of Western Shooting IČO: 36094765, with its registered seat at Hronsek 90/88, 976 31 Hronsek, Slovakia ("SAWS").

Match participant duly notes that SAWS is entitled to collect, process and keep personal data of match participants for the purpose of match organization and realization of sporting activities and other activities for which SAWS was founded and to which it contributes.

SAWS therefore processes all data provided by the match participant in connection with his/her match registration or with the rights and duties of the match participant as required by the match rules.

The data includes mainly name and surname, alias, category, date of birth, address, e-mail and phone number ("Personal data"). Match participant further agrees that AWS can collect, process and keep his/her Personal data for the following purposes:

- a) Creation and administration of the database of the participants of the shooting sport;
- b) Registration and administration of the user account on the AWS electronic portal;
- c) Providing information to the membership applicants, members and match participants.

Provision of the Personal data for these purposes is voluntary. Match participant duly notes that the Personal data necessary for the purpose of organization of the shooting matches are kept for the time of the match preparation, duration and evaluation and for future matches and for any time necessary to fulfill all these purposes. The match participant can revoke his consent with processing of his Personal data in writing, by email or by phone any time.
